

Instructions for Name Change – Adult

Packet contains: Civil Information Sheet – Petition for Change of Name – Notice by Publication –
Notice by Mail – Order Changing Name

Caution: Use of forms without the assistance of an attorney could harm your legal rights. You may want to have an attorney review your completed forms before you file them with the court. These are basic forms and may not cover every situation.

Read Directions Completely – Please Type or Print Neatly

1. Petitioner: Complete a Civil Cover Sheet. You will only need to complete the Plaintiff information section. When selecting the nature of the suit, mark the “Other Civil” box located in the civil section.
2. Complete the Petition for Change of Name except for the case and court numbers. Insert only your **YEAR** of birth where indicated. Fill out the Self Represented Litigant Certification Form.
3. Sign the Petition for Change of Name. Your signature is your affirmation that you are not requesting the change of name for any improper purpose, it is allowed under current law, and that all of the information in the petition is accurate to the best of your knowledge.
4. File the original and 1 copy of the Petition for Change of Name with the Clerk of the District Court in the county in which you reside and pay the required filing fee. (Check with the Clerk to find out the fee applicable in your county.)
5. Obtain the case number and court division assignment from the Clerk of the District Court when you file.
6. Give notice as required by the court.

Notice by Publication requires you to publish notice of the hearing once a week for three consecutive weeks in a newspaper that is authorized by law to publish legal notices and is published in the county where the action is filed. **No judgment can be entered until the proof of service is approved by the court and filed.** The newspaper may send a statement of publication directly to the court or to you. If it is sent to you be sure to bring it with you to the hearing for filing with the Clerk of the District Court.

Each Notice by Mail should be sent by registered mail – return receipt requested. Bring the return receipt(s) with you to the hearing for filing with the Clerk of the District Court.

7. Contact the Administrative Assistant for the court to which the case has been assigned and ask for a date and time for a hearing before the court and what the court requires for notice (publication, mail or both).

8. Complete the Order Changing Name for the judge's signature. Bring it along with proof of notice of the hearing (see # 6).
9. After your hearing, make several copies of the signed Order Changing Name. File the original Order Changing Name with the Clerk of the District Court and ask the Clerk to file-stamp the additional copies at that time. (Social Security, credit card companies, etc. will need a file-stamped copy of the Order.)

IMPORTANT INFORMATION ABOUT BIRTH CERTIFICATES

You are not required to report your name change to the Office of Vital Statistics. Send a file-stamped copy of the Order Changing Name to Vital Statistics, along with a request letter and the appropriate fee, **ONLY** if you want to amend your birth certificate to reflect your new name.

Lea las instrucciones por completo – escriba o imprima correctamente

1. Demandante: Complete la Hoja de Información Civil. Solo necesitara completar la sección de información del demandante. Al seleccionar la naturaleza de la demanda, marque la caja “Otro Civil” ubicada en la sección civil.
2. Complete la Petición de Cambio de Nombre a excepción del caso y los números de corte. Inserte solo su AÑO de nacimiento donde se indique. Llene la forma de certificación de litigante autónomo.
3. Firme la petición de cambio de nombre. Su firma es su afirmación de que no esta solicitando el cambio de nombre para ningún propósito indebido, esta permitido por la ley actual y que toda la información en la petición es precisa a su leal saber y entender.
4. Presente el original y una copia de la petición de cambio de nombre ante la secretaria del Tribunal de Distrito del Condado en el que reside y pague el costo de presentación requerida. (Consulte con la secretaria para averiguar el costo aplicable en su condado).
5. Obtenga el número de caso y la asignación de la división judicial de la secretaria del tribunal de distrito cuando solicite su caso.
6. Dar notificación según lo requiera la corte.

Notificación por publicación requiere que publique el aviso de la audiencia una vez a la semana durante tres semanas consecutivas en un periódico que este autorizado por ley para publicar avisos legales y se publique en el condado donde se presentó la acción. **No se puede dictar sentencia hasta que el tribunal apruebe y presente la prueba de notificación.** El periódico puede enviarle una declaración de publicación directamente al tribunal o a usted. Si se lo envían, asegúrese de llevarlo a la audiencia para presentarlo ante la secretaria del Tribunal del Distrito.

Cada aviso por correo debe enviarse por correo certificado, se solicita acuse de recibo. Lleve el acuse de recibo a la audiencia para presentarlo ante la secretaria del tribunal de distrito.

7. Comuníquese con la asistente administrativa del tribunal al que se asignó el caso y solicite una fecha y hora para una audiencia ante el tribunal y lo que el tribunal requiere para la notificación (publicación, correo o ambos).

8. Complete la Orden de cambio de nombre para la firma del juez. Tráigala junto con el comprobante de notificación de la audiencia (vea el #6)
9. Después de su audiencia, haga varias copias de la Orden de cambio de nombre firmada. Presente la orden de cambio de nombre original a la secretaria del tribunal de distrito y pídale a la secretaria que presente y selle las copias adicionales en ese momento. (El seguro social, las compañías de tarjetas de crédito, etc. Necesitaran una copia de la Orden sellada en el archivo).

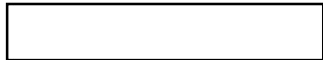
