3. The requestor of the documentation maintained by the Kansas Office of Vital Statistics is  
 the Adult named in the above caption

4. Requestor appears Pro Se by attorney.
5. If the requestor is a legal guardian, the guardianship documentation is provided for the court's review.
6. A certified copy of the amended birth certificate in question is provided to the court.
7. For good cause shown, the court orders release of requested documents under K.S.A. 2019 Supp. 23-2222. Upon  
receipt of this Order, the Kansas Office of Vital Statistics shall release to requestor the VS-211 documents used to  
amend the birth certificate in this matter.
